Sir/Madam,

This office vide its letter No: 5309/Pyt/2011/CEO/5430-61 dated: 25.04.2011, had issued instructions regarding the eligibility of Ration Dealers, who are either Govt employees or are supplying ration to the people on behalf of the government on commission basis and their eligibility to take part /contest in the ongoing Panchayat Election thereof. The above said instructions were issued on 25.04.2011, when the elections for 4 phases of Panchayat Election had already concluded and the scrutiny of nomination papers completed and the list of validity nominated candidates in Form PEL-9 prepared for the blocks falling upto the 8th phase of elections.

Keeping in view the above stated facts, it is clarified that a Ration dealer working on commission basis shall only be allowed to contest in Panchayat Election subject to the condition that he/she should file an affidavit along with the nomination papers, duly attested by Magistrate/ Notary by or before the date of scrutiny of nomination stating therein that if he /she gets elected, he /she will retain either Ration dealership or the post of Panch /Sarpanch. A final choice in this regard will be made by the elected Sarpanch/Panch within a period of 15 days of the declaration of the result. Necessary instructions may be communicated / issued to all the Returning Officers (ROs')/AROs.

Matter may be treated as Election urgent.
