The Election Commission of India has ordered Special Summary Revision of Photo Electoral Rolls in all the Parliamentary/Assembly Constituencies in the State with reference to 01-01-2018 as the qualifying date as per the below mentioned schedule:

The Draft Photo Electoral Rolls-2017 will be available at District Headquarters/Tehsil Offices/Offices of Srinagar and Jammu Municipal Corporations/ Booth Level Officers at Polling Station level and on the website of the Chief Electoral Officer, J&K (<http://ceojk.nic.in>.) for the information of all concerned.

Assistant Electoral Registration Officer (Migrant) in Delhi and Jammu shall receive the claims and objections from the Kashmiri Migrants living within their jurisdiction as per the schedule mentioned above.


All individuals who are 18 years of age or above as on 01-01-2018 can get their names enrolled in the electoral rolls by filing Form No. 6 alongwith two coloured photographs for getting "Electors Photo Identify Card" (EPIC). The persons who intend to object to proposed inclusion of names or seeking deletion of names objections by filing Form No.7. Electors who wish to apply for correction to their particulars should submit Form No 8. In case of shifting of name from one constituency to another due to change of residence, the concerned person/ applicant can fill in Form No. 8A and submit it before the concerned ERO. It should be noted that registration as a voter in two places is an offence under the J&K, Representation of People Act 1957.

All stakeholders are therefore, requested to participate in revision exercise in order to ensure that maximum number of eligible voters are enrolled in the Electoral Rolls.
