## Notification

JAMMU, DATED THE 29<sup>th</sup> OCTOBER, 2018

WHEREAS, under J&K Panchayati Raj Rules, 1996, the Government of Jammu and Kashmir, vide SRO No. 405 dated 16<sup>th</sup> September, 2018, issued notification calling upon all the Panchayat Halqas of the State to elect Sarpanches and Panches; and

WHEREAS, accordingly the Chief Electoral Officer has announced the schedule of elections to Panchayat Halqas in the State;

NOW THEREFORE, in exercise of the powers conferred under section 36 of Jammu and Kashmir Panchayati Raj Act, 1989, read with Rule 8 of the Jammu and Kashmir Panchayati Raj Rules, 1996, the Election Authority, J&K (Chief Electoral Officer, J&K) hereby appoints the following dates for the conduct of Phase – III elections in respect of the Panchayat Halqas in Blocks mentioned in the Annexure appended to this Notification:-

- a) the 29<sup>th</sup> October, 2018 (Monday) as the date of issuance of the Gazette Notification.
- b) the 5<sup>th</sup> November, 2018 (Monday) as the last date for making nominations.
- c) the 6<sup>th</sup> November, 2018 (Tuesday) as the date for the scrutiny of nominations.
- d) the 8<sup>th</sup> November, 2018 (Thursday) as the last date for withdrawal of candidature.
- e) the 24<sup>th</sup> November 2018 (Saturday) as the date on which a poll, if necessary, shall be taken from 08:00 a.m. to 02:00 p.m.
- f) the 24<sup>th</sup> November 2018 (Saturday) as the date of counting, unless notified otherwise.
- g) the 17<sup>th</sup> December, 2018 (Monday) as the date before which the election shall be completed.
